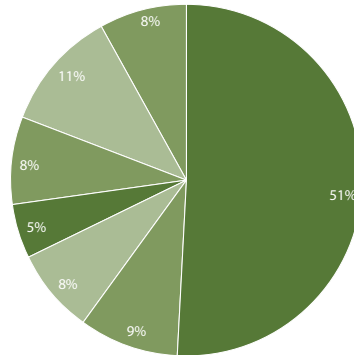

Dear Westminster Family,

September 2008 was a month that changed the economic world as the system we had depended on over the last 60 years teetered on the brink of disaster. We have had to realize that the "normal" we had known was not coming back and that we were in a bona fide recession. This downturn had huge implications for churches and non-profits throughout the world. We all began to realize that we must adjust to a new

reality and, as a group of leaders, we were being asked to lead in a new way.

We responded to our reduced revenues by revising our original budget of 2008-2009 to reflect the unknowns (*Columns 1 & 2*). We slashed our expenses and began a thoughtful plan to address a longer-term shortfall should the downturn continue. In early 2009, it became apparent that our only unexercised option to lower costs was ministry reorganization and the reduction of human resources by

nearly 39%. This was an agonizing time for our church family as our staff was repositioned and hours were cut.

A new budget is projected for 2009-10 which reflects our new reality (*Column 4*). We have attempted to provide sufficient resources to maintain our wide range of programming for all ages and ethnicities, while continuing to fund our Next Chapter responsibilities. We remain committed to our over-riding vision and mission to our community and the world.

Westminster Chapel is poised for the reality of a new way to minister – one that will look to each member to be more fully engaged in prayer, discipleship, and service. We are confident that your participation will lead to a more enriched and vibrant church family as we continue to deepen our relationships with God and each other.
